Planning Commission; Meeting was held on March 7. Nick Weidling was absent.

There were a few residents who came to the meeting with concerns about his planned development. The committee took their questions and answered them the best they could (see planning minutes).

Paul reported that the owners of the trees on 160th had started trimming the trees that are in the ROW, they will have to meet the clearance and visibility and will be monitored.

Approval of a stop sign on 160th RR crossing – Motion by Aune/Anderson second.

Roads:

Posted the roads on March 16th. Put red reflectors on the stop signs 170th and 190th.

The bridge on 160th street between Hwy 12 and 100th needs to be widened, looking to see in it will accommodate a wider bridge deck.

Plan to resurface 170th between 100th and 110th, Paul will get an estimate.

Plan to shoulder 170th St. between Hwy 12 and 100th.

Paul discussed the Bipartisan infrastructure bill currently being looked at, if passed, we could apply for some of the funds, looking into what it costs to submit an application.

Chairman report: Paul met with Union Pacific, WI DOT, St. Croix County and the OCR to discuss changes to our RR crossing. Items that were discussed and decided upon:

We will not be closing any of our current crossings. All crossings will be painted with passive crossings on the pavement; the snowmobile crossing on 200th will need to be changed, they must go straight across the tracks not at an angle. The trail to the south they would like closed. All crossings 150th, 160th, 170th, 190th will all have stop signs on the RR posts, we are responsible for the Stop Ahead signs. The RR is responsible for all costs at the crossings. 200th will have crossing arms, there is electricity already there.
