Discussed the missing signs on 110th, it was determined that had been cut and removed by someone, county will replace. The bridge on 160th street between Hwy 12 and 100th is only 19.8 feet wide, the county is working on what can be done. Plan to resurface 170th between 100th and 110th, this project was approved for LRIP funds.

Chairman report: Paul discussed the Bipartisan infrastructure bill currently being looked at; the thoughts were from the board that we continue with our road paving as we have done in the past.
