Annual report – motion to approve Wynveen/Anderson second

Approved the liquor applications from the HGC and Pheasant Hills golf courses; Motion by Anderson/Miller second. Approved the operator licensees for the HGC and Pheasant Hills golf course; motion by Miller/Aune second.

Roads:

Paul discussed scaling back road project due to cost. Will complete spray, chip and fog plans of 11.3 miles. Paul will meet with county to review damage caused by storm debris from the Airport Sky Diving facility 200th Street and 60th Ave. Paul asked if Linda would check with the Register of Deeds to see if we have to register the Joseph Shakal road waiver.

Chairman: Paul completed an application for the Bipartisan Infrastructure bill, the total cost of the 3-mile project for 90th Ave. would be \$2,564,905 with us having to pay 20% \$520,000. Waiting to see if the application is approved, if approved does not mean we have to do it.
