Citation Ordinance # 2015-01 Amended and Restated

SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Hammond (Town) Citation Ordinance. The purpose of this Ordinance is to authorize the Town Board of the Town of Hammond, or its designees to issue citation for violations of Town ordinances, including ordinances with statutory counterparts.

SECTION II - AUTHORITY

The Town Board of the Town of Hammond, St. Croix County, Wisconsin, has the specific authority under § 66.0113, WI Stats., to adopt this Ordinance. This Ordinance provides the authority for the Town to issue citations for violations of Town ordinances, including those with statutory counterparts.

SECTION III - COVERAGE

A. The form for the citation to be issued in the Town by the Town Board, or its designees, for violations of Town ordinances shall be as provided in § 23.54.

B. A direction that if the alleged violator elects to make a cash deposit, the alleged violator shall sign an appropriate statement that accompanies the citation to indicate that they read the statement required under § 66.0113(1)(b)7., Wis. Stats., and shall send the signed statement with the cash deposit.

C. The town Board has adopted or will adopt a schedule of cash deposits that are required for the various Town ordinance violations, which includes for each listed violation the costs, fees, and surcharges imposed under Chapter 814 Wis. Stats..

D. The Town Board names the following court, clerk of court, or other official to whom cash deposit are to be made and requires that receipts shall be given for cash deposits: St. Croix County Clerk of Court.

SECTION IV - ISSUANCE AND SERVICE OF CITATION

A. Town citations may be issued by the following:

1. Town Chair.
2. Any other Town or County official, or Town designees, designated by the Town.
3. Any law enforcement officer.
4. Town appointed animal control/humane officer.

SECTION V - RELATIONSHIP TO OTHER LAWS

The adoption and authorization for use of a citation under this Ordinance does not preclude the Town Board of the Town from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or any other matter. The issuance of a citation under this Ordinance does not preclude proceeding under any other ordinance or law relating to the same or any other matter. Proceeding under any other ordinance or law related to the same or any other matter does not preclude the issuance of a citation under this Ordinance.

SECTION VI - SEVERABILITY

If any provision under this Ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are severable.

SECTION VII - EFFECTIVE DATE

This Ordinance is effective on publication or posting. The Town Clerk/Treasurer shall properly post or publish this Ordinance as required under §60.80, Wis. Stats.

Ordinance # 2016-002 Section IX Dogs Barking:

Upon conviction the owner of such dog shall pay

1st offense shall be an amount not less than \$25.00 nor more than \$50.00.

2nd offense shall be an amount not less than \$50.00 nor more than \$100.00.

3rd offense shall be an amount not less than \$250.00 nor more than \$500.00.
