The board for the Town of Hammond held their regular monthly meeting on Tuesday, April 22, 2025, at the Hammond Town Hall at 1816 County Road E.

Chairman Hueg called the Town of Hammond Board meeting to order at 8:00 pm.

The agenda was approved motion by Anderson/Aune second.

The bills and payments were approved; motion by Wynveen/Miller second.

Recycle Report: Quiet, all good. The compactor will be emptied once a week. Starting May 1, the recycle center will begin taking appliances, there will be a fee for each appliance. They will also be taking tires, \$10 per tire this only includes cars and trucks.

Planning Commission:

The meeting was dedicated to the Xcel Solar farm project. Xcel pushed back the date to September for submitting to the PSC. See more information on the Planning Meeting discussion in there minutes on the website.

Agenda:

Town Hall Rental: No changes will be made to the charge for rental or a cleaning charge; motion by Wynveen/Aune second. Will review this at budget time and/or Annual meeting.

Comprehensive Plan: Proceed the County on the plan, motion by Wynveen/Miller second.

Ordinance review; Health and Safety Solar Ordinance; this was tabled to give board members time to review. Will review again at the May meeting.

Roads: Road restrictions were removed on April 21. 110th Ave. is due to be done this year, it is an LRIP project. Paul is concerned that if we do the project this summer, the Autumn Woods development project could potentially damage the roads when that gets under way. The board feels we should do the road as it is really in bad shape. We have seven years to use the LRIP funds.

There was a school bus driver present and requested a school bus sign on 160th – pine trees are a hinderance.

There was a discussion on replacement fire signs, the board decided if you want a new one just because they are nicer looking, the resident will have to pay for the sign and install it in a proper manner.

Chair: A letter was sent to a resident for violating road restrictions. The Weber property had had many complaints and is now in violation of Chapter 15.

The back parking lot can't be blacktopped by the county unless we put it out for bids first. There was discussion on using crushed recycled blacktop, Paul will look into this more. We received the County aid application for the 200th Street bridge (Ogden County Aid Pipe), which will be repaired. It is eligible for 50% county aid. Linda will get it sent back to the county.
