Agenda:

Autum Woods: Angela Popenhagen was present as the towns engineer on the project. The project was given the go ahead to start on the infrastructure, prior the final plat. They cannot sell any lots until final plat.

We have 8 miles to chip/seal and spray patch. The 200th Street bridge will also be repaired. The county is currently doing shouldering, overall are roads are in pretty good shape.

Chair: Matt Hawkins is doing the back driveway. Drain tile, Gravel and recycled blacktop. He will also sweep the parking areas

The SCC central students who were here for the community service project did a great job in cleaning up the grounds.

Linda suggested we look into adding a pickle ball court, she will do some investigating.

The board will start working on the comprehensive plan with county in June/July time frame.
