The board for the Town of Hammond held their regular monthly meeting on Monday, October 13, 2025, at the Hammond Town Hall at 1816 County Road E.

Chairman Hueg called the Town of Hammond Board meeting to order at 7:30pm.

The agenda was approved motion by Anderson/Aune second.

The bills and payments were approved; motion by Miller/Wynveen second.

Planning Commission:

The first two hours were devoted to the Comprehensive plan. St. Croix County representatives were on hand to share the survey results and answer any question.

Autumn Woods final plat was discussed; the roads passed the roll test requirements. The covenants were reviewed by Cole Sutheimer and Paul. Autumn Woods must use numbered streets and avenues for addresses.

Paul shared updates on the Xcel Solar Farm.

Agenda:

Autumn Woods – the final plat was approved; motion by Aune/Anderson second. The first layer of blacktop is down and they are seeding and restoring.

Wyatt Porter, was present to discuss the invoice he got from the Town for road damage at 150th and Hwy 12. He was doing some ditch work with heavy equipment during road closures. In the process he damaged the roadway. The County was called to fix it and Wyatt was billed for the work.

Pavillion Roof – we got an updated estimate from MAS; they would donate the shingles and all we had to pay for was the labor. Also asked if they were doing a drip edge and could they add aluminum fascia. If they come back with yes, all for \$3500 or less, to go ahead with the project.

Budget review – Linda had a rough draft of the budget worksheet to review; the numbers still have to be firmed up for the November meeting. The one item that came up for discussion was \$85K for two new pickle balls courts at the town hall. Paul felt uncomfortable just going with that kind of a number without the residents having some knowledge of the expense. It was decided that at the November public hearing and Town Electors meeting it would be on the agenda. The date and time will be noted on the Website.

Roads: The second lift is done on 110th, not sure if shoulders or if restoring is being done. The county paved 119th St., 66th St. got paved in Hammond Hills, paved 1 Cul de sac on 166th. Paul is checking to see if any other Cul du sacs are going to be done.

Trees on 160th on the curve are staked to see what trees are in the ROW.

Chair: Paul reported Deaf child signs were ordered for a street in Rolling Hills. SCC Rec is requesting if they can add some storage space at the ball fields.

Next meeting scheduled for November 10, 2025

Being no other business, the meeting was adjourned, motion by Anderson/Miller second.
